

## **RESOLUTION**

### **R196-06/07**

**WHEREAS** the City of Selma invited and accepted bids during the month of May 22, 2007 through June 5, 2007 on a bid proposal on Nine (9) Condemned Houses (060507). Further detailed specifications were given in the Bid (060507); and

**WHEREAS** the City Clerk has complied with Sections 41-16-50 through 41-16-63 of the Code of Alabama, 1975, by advertising the bid in City Hall and further by notice to selective vendors; and

**WHEREAS** the City Clerk opened the sealed bids on June 5, 2007 and Tyus Trucking and Construction Company was the only responsible bidder.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SELMA AS FOLLOWS:**




